Memories of Pig Roasts Past -- Math Howell and the Sales Stars of Missouri Portland Cement were starters of the annual contractors Pig Roast in the late '60's. Math and his salesmen and close friends and customers would cook all night and deliver the food for the feast.

In 1968-69 more Sponsors joined and the crowd gathered at the Stewart-Nattinger Company yard near the concrete block production plant. Chris Nattinger and Leroy Yarbrough of the company were major Nattinger men making it happen, along with Bob Smith of the company. They did it there three years and gained Sponsors.

Memories of Pig Roasts Past continued ... John Griesemer, Griesemer Stone Company, was a Sponsor along with Smith Calhoun of Springfield Ready Mix. Knopke Brothers Supply and Bob Smith with his awning company became Sponsors. Other companies joined to cover the increasing costs.

The growing crowd caused a move to the Griesemer Stone Company underground areas for several years; then it moved on to Pat Jones Buena Vista Ranch. In 1984 the Sponsors worked with the Springfield Contractors Association to make it their fundraiser to support a professional staff.

Jim Cobban then led the group and formed a hard-working faithful SCA team at Jones Ranch. Larry Ruckman then (with NO BS leadership) was a great leader. Then Mark Elwood took charge. Danny Edwards then became the responsible leader with Rick Shirrell as co-leader. Each person named had worked together for years and amazing hard work evolved in the hot July event.

The river changes course each year and Cliff Kennedy always sent men and equipment (at his own expense) to prepare the parking areas for the crowds of people. ESS inherited this job when they acquired Kennedy Contractors and it is a vital contribution to everyone who uses the park.

It takes many people to make this event happen. Sheryl Letterman and Kathy Baer became important cogs as they joined the SCA staff. Carrie (Parks) Quesenberry has been the point person for the Greeters and Nametag group and she can sell anything: hats, t-shirts, bandanas or buttons. The Bar Crew was led by Jack Stapp for more years than any of us can remember, with help later on from Mike Henning. Now Bryan Cox and Mark Gambon have streamlined service and they have help from many great people who serve the beverages with a smile. The various beer reps have been so good to us, especially Chico and his sidekick Brad.

The Food Serving group has had many leaders and workers. Ones I remember are Deb Ferguson and Diana Dohmen, along with the crew slicing and prepping the food line. The Christian County Shrine Club joined the effort to cook and serve their Beans Plus. Security was added with the Shrine BATS, who also help with parking. Both Shrine Clubs donate the money they receive to the Shrine Hospital for Crippled and Burned Children. They have accepted less from SCA during recent low attendance periods.

Hoffman Pest Control has for years sprayed the grounds prior to the event with little or no pay. Louis Griesemer and Bob Jett of Griesemer (Springfield Underground) organized groups to clean up early the next day along with many others including Leroy Yarbrough. Bob Dock's Boy Scouts took over cleanup, followed by Jerry Miller's Scouts. Now Ken Turner and his boys handle cleanup duties.

There are so many dedicated people that we cannot name all who have sweated and worked for the good of all. Mrs. Pat Jones and her employees and family have been so great to work with SCA through many years, even when she stopped allowing others to have events on the ranch.

SUMMARY OF DISCUSSION AT JUNE 15 BOARD MEETING:

President King Coltrin called the meeting to order. Fifteen Board Members were present. The Minutes, an abbreviated Treasurer's Report and one new member were accepted.

The Spring Golf Outing was successful with 112 golfers filling the course. We will limit the August Outing to afternoon only and revisit the option of a morning session next year.

The AIA/Government Liaison Committees reported the Task Force discussing closeout issues will meet July 11. More Subs will be invited to participate in the discussions. The Fire Department made a presentation regarding increased enforcement of fire lanes and how this will affect parking lot striping and plan review. We have not been able to establish a link to the powerpoint on our website yet. Electronic plan review by the City should be available by Labor Day. There is some question about the quality of computer necessary to run plans but a computer that can run Autocad should be able to upload plans to the program instead of printing them and physically delivering them to the City. Training should be minimal and this will mean faster turnaround in BDS. An important factor will be correctly naming and identifying the sheets in each set of plans.

The Construction Employment Service has received a few calls for employees during the last month.

The MSU Liaison Committee reported multiple jobs are featured on their website (http://plans.missouristate.edu/) as bidding in the next few days or weeks. The committee discussed the short time frames allowed on some projects and how high liquidated damages can affect the quantity and quality of bids. The classroom upgrade at the sports complex will be rebid soon with the start of construction to begin after the football season. Redesigned plans for the Vivarium (all bids came in over budget) will be out soon. The Walnut Street project came in over budget and will be redesigned. It was noted that the first addenda for the Walnut Street project was 325 pages long and came out the same day as the pre-bid conference.

The R-XII Liaison Committee reported they discussed maintenance projects and the practice of allowing a manufacturer to design projects and then bid only the labor. This saves on design costs but may not offer the best option for materials. The District has some parking lots out for bid. Four of the seven bidders on the athletic fields were thrown out for lack of DBE paperwork.

Vice President Dave Foreman will chair the Nominating Committee for 2013 Board elections, with help from past presidents Rich Kramer and Dave Robertson.

The Board will recommend the dissolution of the Springfield Contractors Association Political Action Committee to the SCAPAC Board and let them decide what to do with the rest of the money in the bank account.

Bringing Pig Roast attendance back to the level before the slowdown will be the major emphasis this year. We will have some four color posters and a slide show to generate interest and encourage people to "come back" to the party. The Board agreed they could each sell at least five tickets.

There being no further business to discuss, the meeting was adjourned.



Location of Project:

- The project <u>must</u> be located within a 50 mile radius of downtown Springfield, Missouri.
- Team members do not have to be located within the 50 mile radius, however the point criteria will be distributed based upon the team's office location in proximity to the 50 mile radius designation.

Creativity / Uniqueness of Design:

- Describe how the design goes beyond typical ideas and creates new ideas, forms, methods, interpretations, etc.
- Include any special characteristics of the project such as:
 - o Unique Material Use
 - o Sustainable or "Green" Elements / Features
 - o Other

Functionality of Design:

- Describe the project type and the design solution.
- Include any special constraints such as:
 - Site (infrastructure, topography, etc.)
 - o Budget
 - o Other

Overall Quality of the Project:

- Describe the project delivery satisfaction between Owner, Consultants, & Contractor.
 - o Was the Project Budget met (including construction, furnishings, fees, etc.)?
 - o Was the Project Schedule met or completed early?
 - o How does the project impact the community?
- Describe the level of craftsmanship and special skills displayed by a Trade (or Trades) to complete the project.

Design & Construction Team Relationship:

• Describe the relationship of the Design & Construction Teams and the collaboration of their efforts to complete the project.

Descriptive information may be attached to the form if additional space is required.

Photographs of the Project are highly recommended (maximum 5 per entry), but are not required. If provided, photographs should be submitted <u>electronically</u> with the nomination form.

- 2. Photos are to be classified as **(A)** Faces in Construction, or **(B)** Places in Construction. Faces are "candid" pictures involving **people at work** on job sites or projects under construction. **All others** will be Places. Photos may be interior or exterior shots of any aspect of the design and/or construction industry and may be taken anywhere by a qualified photographer (see #4).
- 3. To promote safety awareness, no photo showing any unsafe practices or conditions will be allowed. A Review Team from the Safety Committees of Salute sponsoring organizations will screen the photos prior to judging and will disqualify any photo which does not meet safety standards. The Review Team's decision to disqualify will be final and not eligible for appeal.
- 4. Entrants must be amateur photographers who are members of at least one of the participating organizations or member firms' employees. **Entries are limited to a total of two photos per photographer**.
- 5. Photos may be black-and-white or color. Digital files are **strongly preferred**, but paper prints will be accepted.
- 6. Digital files can be emailed to salutephoto@gmail.com or submitted on CD. Files must be in JPG format with a minimum resolution of 1600x2000 pixels. Emailed entries will receive an email confirmation. Emailed entries must include information on entry form. Entry forms can also be faxed to 417-883-9403.
- 7. Photographic prints must be submitted as an un-matted 8x10. Photo must have entry form attached to back of photo so name of entrant is not visible to judges. Prints must be delivered to The Builders' Association at 521 South Ingram Mill Road by 4:30 PM, Friday, October 5, 2012.
- 8. Photos will be judged on a point system and cash awards made as follows: Best of Show \$100; First place \$75 (each category, Faces and Places); Second Place \$50 (each category); Third Place \$25 (each category). A total of \$400 will be awarded.
- 9. Photos will be displayed and awards will be presented at the Salute to Construction "Awards Ceremony and Banquet" on **Thursday, November 1, 2012.**
- 10. Judges' decisions will be final.

Proposed Transportation 1/8 cent Sales Tax Renewal Projects 2013-2016



- A Mount Vernon Street & Orchard Crest Avenue
 Design, acquire right-of-way and construct improvements at this
 intersection to improve safety, capacity and drainage.
- B Chestnut Expressway & Railroad Crossing West of US 65' Construct Chestnut Expressway Bridge over the Railroad, to eliminate the Railroad Crossing.
- C US 65 & Battlefield Road
 Replace Battlefield Road bridge over US 65, add additional ramp
 lanes, and construct a double diverging dimensional interchange.

City Wide Intelligent Transportation System (ITS) and Signal System Improvements

The City of Springfield and MoDOT are developing an Intelligent Transporation System that includes enhanced traveler information, coordinated traffic signal operations and upgraded software and hardware, and emergency response efforts such as Amber Alerts and Homeland Security Advisories.

City Wide Major Street Resurfacing/Rehabilitation

Safety Doesn't Cost - It Pays!

Wake Up America! Are you getting enough sleep? Many of us are not getting the required sleep we need and the results both on and off the job can be devastating. While heart attack, cancer and strokes are the leading causes of death in the US, motor vehicle accidents are the second leading cause of accidental death in this country (according to a 2011 report, drug overdoses overtook car accidents for the No. 1 spot in 2009). Motor vehicle accidents typically kill 35,000-45,000 people annually.

According to the NHTSA, there are more than 56,000 accidents attributed to **driver fatigue** in the US each year. One study calculated that 17% (about 1 million) of road accidents are sleep-related. These accidents kill at least 1,550 people annually and contribute to 40,000 non-fatal injuries. Summarizing the US Department of Transportation's investigations into fatigue in the 1990's, the extent of fatigue-related fatal accidents is estimated to be around 30%.

Early hours of the morning (between midnight and 6 am) and the middle of the afternoon are the peak times for fatigue accidents. Driving for just 80 minutes without a break can make motorists a danger on the road. In a recent survey 60 percent of Americans polled admitted to driving while drowsy. 31% of respondents admitted having fallen asleep at least once while driving in the last twelve months. – SmartMotorist.com and NHTSA

What can you do?

Don't drink and drive
Carpool if you can
Try to keep a regular sleep cycle
Ingest some caffeine and keep a window open for fresh air
Pull over if you are tired or feel yourself starting to doze off
Make a short stop every hour or so to get out of the vehicle


