Lifetime Achievement Award

Purpose of the Lifetime Achievement Award

The Lifetime Achievement Award is meant to recognize individuals who have made a significant impact on the Design and Construction Trades industry in the Springfield, Missouri area. The recipient(s) will be recognized at the annual Salute to Design and Construction Awards Banquet in November.

Who Can Nominate?

Award nominations will be accepted from members, including self-nominations, of any of the organizations represented in the Salute to Design and Construction Council as well as the general public.

Who is Eligible?

Individuals who work or have worked within the design and construction trades industry may be considered for the Award. The section committee will consider all people in the Springfield, Missouri area regardless of age, race, sex or religion.

Recommended Criteria *(must use five for nomination)*

Applicants could have....

- Made a lasting contribution to the Design and Construction Trades industry
- Served 25 years or more in the industry
- The respect of local peers
- Exhibited leadership and provided inspiration to others in the industry
- Achieved a position of significance and authority enabling them to influence and/or make policy decisions beneficial to the Design and Construction Trades industry
- Encouraged and empowered others in the industry through establishing company policy, enacting legislation or initiating organizational structure
- Actively promoted the inclusion and/or advancement of others in construction
- Showed leadership in taking initiatives or risks on behalf of others in construction
- Successfully broke barriers with a "first" in construction
- Acted as a role model and/or mentor
- Held positions of leadership, such as membership of industry boards, or chair of committees and community organizations

*Applicants are not required to fulfil all the above criteria. The recommended criteria are solely provided as possible criteria suggestions.

Nomination Process Details

The award winner(s) or someone close to the winner will be contacted by phone and requested to send photos with additional personal and/or professional information to be used during the Salute to Design and Construction Awards Banquet. The selection committee reserves the right to determine the number of nominees who will be chosen for the Award each year based on the number and quality of applications.
