C. SCOPE OF WORK

The work includes, but is not limited to, the following:

Provide all labor, equipment and materials to construct On-Site Sodium Hypochlorite Generation facilities for the Fulbright Water Treatment Plant. Facilities include a cmu block building with brick veneer approximately 64'L x 63'W x 14'H ceilings with attached brine tank room measuring approximately 27.5'Lx17.5'Wx19'H. Building roof will be precast double tees supported by (8) precast columns on micro-pile foundations. Work includes but is not limited to: masonry wall construction, indoor piping and electrical, sanitary plumbing, water piping, yard piping and electrical, a gravity block retaining wall, asphaltic and concrete pavement work, lighting, and electrical including 480V switchgear. All work and materials will be provided according to the contract documents contained herein.

The chemical storage, processing, and feed systems that will be housed in the new building will be purchased and installed by the OWNER.
