C. SUMMARY SCOPE OF WORK:

Main Office Patio Roof: Remove existing elevated paver system from existing roof patio area on main office building. Provide new roof membrane and cover board over existing roof system. Provide new elevated roof paver system. Provide new perimeter roof to wall flashing and modify existing roof drains.

Roof Maintenance and Repair Work: The work includes, but is not limited to the construction and/or the installation of the following: Provide "on call" maintenance or repair to the various types of roofing on City Utilities' facilities via individual task orders. Generally the work will be on City Utilities' property, and at times may be on private property not owned by City Utilities. Contractor may be required to visit job site and prepare a written estimate for each job <u>before</u> work begins, unless otherwise instructed by a City Utilities' Authorized Representative. Prevailing wages shall apply for all work.

D. PRE-PROPOSAL CONFERENCE:

A pre-proposal conference will be held on March 10, 2016 at 10:00 a.m. in the City Utilities Training Center located at 301 East Central, just north of the main office building.

Participation in this Pre-Proposal Conference is not mandatory, but it is highly recommended.

E. PROPOSAL OPENING:

All proposals, whether mailed or hand delivered, must be in the hands of the Purchasing Agent of City Utilities at the address provided in RFP Section II-F (*Marking and Mailing Proposals*) by the Bid Opening date and time, which is **2:00 P.M.**, (Local Time) March 17, 2016. Any bid received after such date and time will be rejected.

Proposals will not be publicly opened or read since the selection process will be determined based upon competitive negotiated procurement procedures for proposals as described in this RFP.
