C. SUMMARY SCOPE OF WORK

The Work associated with the Coal Combustion Residuals Clean-Up will consist of providing all labor, materials, equipment, tools, transportation, insurance and services for the planned clean-up at City Utilities of Springfield's James River Power Station (JRPS) and John Twitty Energy Center (JTEC).

The remediation project site work is anticipated to begin in the summer of 2016, with an expected continuation through October 2017. The work includes, but is not limited to:

- 1. Removal of coal combustion residuals and soils from multiple on-site storage areas;
- 2. Transport to and placement of materials in on-site utility waste landfills (UWL);
- 3. Vertical extension of the containment embankment surrounding the JRPS UWL; and
- 4. Restoration of all areas affected by the Work.
